

In accordance with Article 108. Public Procurement Law ("Official Gazette of the Republic of Serbia" 124/12, 14/15 and 68/15) and in accordance with Report on expert evaluation of bids no. 954 from 05.04.2017.acting director of Belgrade festivals center CEBEF adopted the following

DECISION

On Awarding the Contract

for public procurement of services in the field of culture - performance within the CEBEF's concert season in negotiated procedure without public invitation to bid - Public procurement number 09/2017

The Contract for for public procurement of services in the field of culture - performance within the CEBEF's concert season in negotiated procedure without public invitation to bid - Public procurement number 09/2017 is awarded to the bidder Impresariat Simmenauer GmbH, Kurfürstendamm 211 DE-10719 Berlin , Germany for the bid number 951 of 05.04.2017.(CEBEF-s reference number).

This decision is to be published on Public Procurement Portal and CEBEF's website within three days from the date of decision.

Explanation

1. In accordance with the Opinion of the Public procurement office on the merits of applying the negotiated procedure without public invitation to bid number No 404-02- 608/17 of 2nd of March 2017, public procurement of services in the field of culture - performance within the CEBEF's concert season in negotiated procedure without public invitation to bid - Public procurement number 09/2017 was initiated by Contracting authority-The Purchaser, in accordance with Decision on Initiating the Public Procurement Procedure No. 881 of 23.03.2017 and Decision on the Formation of Public Procurement Committee No. 882 of 23.03. 2017,

2. Notice on initiating negotiation procedure without public invitation to bid was published by Contract Authority-The Purchaser on Public Procurement Portal as well as on the contracting authority's website on 24.03.2017. in accordance with Public Procurement Law.

3 The public bid opening was conducted on 05.04.2017. in the premises of Belgrade festivals center Serbia, Belgrade, Ilije Garasanina 24, starting at 12.00 hours, in the presence of the Public Procurement Commission, appointed by Decision on Public Procurement Commission no. 882 of 23.03. 2017.

The representative of the Bidder was not present for the opening of the bid, nor was he present for the negotiating procedure.

4. After bid opening procedure, Commission issued Report on expert evaluation of bids 954 from 05.04.2017.and stated following:

- Subject of public procurement: services in the field of culture - performance within the CEBEF's concert season in negotiated procedure without public invitation to bid - Public procurement number 09/2017.

- The estimated value of the procurement: 2.100.000,00 dinars (without VAT) .

- Total bids: 1

- Timely submitted bids (DEADLINE FOR BID SUBMISSION was 5th of April 2017, BY 11.30 HOURS)

- Untimely submitted bids: none

- Rejected bids, the reasons for refusal and prices: none

- Criteria for Contract Award is "lowest price offered".

- Based on the criteria for awarding the contract, the Commission has ranked acceptable bids:

Rank	Bidder	price without VAT
1.	Impresariat Simmenauer GmbH	16.611 EUR i.e. 2.056.800,60 dinars according to the the medium exchange rate of the National Bank of Serbia on the day of the bid opening began (1 EUR=123,8216 dinars)

Since representative of the bidder was not present for the negotiating process, price and other terms stated in the submitted bid are considered the final offer from the bidder.

- The Name of most favorable bidder: Impresariat Simmenauer GmbH, Kurfürstendamm 211 DE-10719 Berlin , Germany for the bid number 951 of 05.04.2017.(CEBEF-s reference number)

5. After review and expert evaluation of bids, the Procurement Commission proposes a decision on awarding the contract in favor of the bidder: **Impresariat Simmenauer GmbH**, Kurfürstendamm 211 DE-10719 Berlin , Germany for the bid number 951 of 05.04.2017.(CEBEF-s reference number)

6. Given the above, the Acting director accepted the proposal of the Commission for public procurement, and on the basis of legal authority, bringing the contract award decision cited above.

Legal remedy: Against this decision, a request for the protection of rights may be submitted to the Contract Authority, within 5 days of publication of decision on Public Procurement Portal. The request

shall be submitted to the Contract Authority and a copy shall be at the same time submitted to the Republic Commission for protection of rights in public procurement procedures.

The request for protection of rights must contain the elements prescribed by Article 151 of the Public Procurement Law.

The applicant is required to pay a tax at the account of the budget of the Republic of Serbia in the amount prescribed by Article 156 Public Procurement Law. In accordance with Article 112, paragraph 2, item 5 of the Public Procurement Law, the Contract Authority may conclude a public procurement contract, before the expiry of the deadline for applications for the protection of the right.
